With WCAG 2.2 compliance now coming into force, My Parish Council are updating the 'back-end' code to allow full compliance. There is no cost associated with this.

WCAG 2.2 consists of 86 success criteria, which are pass or fail statements that address accessibility barriers such as low-contrast text, ambiguous anchor test and keyboard accessibility issues.

My Parish Council are offering a Site Audit at a cost of £50 (ex VAT). A pass/fail notification will be received. If assistance with fixes is required, My Parish Council can offer an estimate for the work.
