- Park Shed management KW. Items within the shed are controlled by the Village Fair committee and managed by the Village Hall committee.

Shed is owned by TPC and the land is leased.

Too much public access to the shed as the key lock is on the side. Items are borrowed and returned but not necessarily in the correct or safe place. Items are being put back wet, wrong parts added to other parts.

Discussed at meeting as to if someone should take ownership of equipment i.e. items booked in and out and the key taken out of the key safe and held by one person.

JM advised that the mowing volunteers will need weekly access.

The key safe number could be changed and the new number only given to the mowers, with everyone else gaining access via KW.

DK will send an email to Chair of Village Hall to advise what has been proposed and then email the residents to let them know that equipment is available to borrow but via KW.

- Village Hall items KW.

Above items raised at previous Village Hall meeting. This will be chased again at the next meeting and emphasis made that action is required.

- Tockenham Parish Site Visit - Flooding Sites, Works List – Report received but we await clarification on who will be responsible for carrying out the works. Areas in report received that require clarification. KW has spoken to David Arnup and he has enlightened KW about who will be responsible for the works. Central Government has funded some money to local councils to allow for ditch works following the floodings. This will be regardless of who owns the land.

KW will send out the reports to the residents who had been affected by the flooding and also copy to councillors.

- Offer of a large quantity of stock fencing (used) could be suitable for the fence around the playground, to keep the balls and children inside.

Existing fence is low and this could help with keeping balls etc in. Discussion around possible condition of the fencing and if it would be worth putting it up. **RW** will have a look at it to see if it is worth using.

Could cause issues with mowing the surrounding area.

- PROPOSED TRAFFIC REGULATION ORDER FOR CONSULTATION – Various proposals for Royal Wootton Bassett, Calne and Tockenham.

Site visit planned for 11th September at Tockenham Corner at 13:00 pm. There are some major proposals for Tockenham Corner and Tockenham Wick junctions, and these will be discussed at this meeting. There will be a third lane for turning right at both junctions and the lower turning onto A3102 towards Royal Wootton Bassett will be blocked.

- Invitation: Community First AGM 9th October 2024 We are now fully signed up members. Have received information that was desperately required once we had paid our subscription. Linked with Village Hall associations. No one to attend AGM.
- Neighbourhood County Parish Forum. Police are inviting Parishes to a County meeting. Most information is received via Safety meetings. Meeting to be held in November, agreed to see what the agenda contains.

- Notes from RWB&C Community Safety Group Meeting 9th August DK. New inspector called Scot Angur. Talk by Jude Deman from Connect about substance abuse in younger people. Next meeting 13th September – I am Road Smart.
- BKVC REPORT. To note – BKV sign removed by new winners - Hankerton. Sign has now been given to representatives from Hankerton.

DK will send report from the Laurence Kitchin competition to residents.

- Town and Parish Council update 26/07/24 - Richard will be interested in the Environment one - but it might be useful for all of us to drop into the library on 11th September.
- Travellers' Plan. DK attended the webinar on 3rd but it was difficult to distinguish the sites at the meeting so it would be worth attending the library meeting to find out more information.
- Wiltshire Bobby Van Trust – Donation request. Unable to support this, **RH** to let Bobby Van Trust know.
- Gypsies and Travellers Development Plan Document 16/07/24. Meeting held 15/07/24.
- JACS (UK) Ltd - Village Gateways - for discussion. To consider later.
- SSEN resilience funding. **RH** to forward email to DK again. To decide what is required for our emergency plan and apply at next funding application.
- Emergency Contact Hubs - sign up – site visit at Hall on 9th September. This visit will determine if the Village Hall is a suitable venue to be used as an Emergency Hub.
- To decide on which flag to fly in Park. DK and KW received an email from a resident suggesting that it was time to take down the Ukrainian flag. Several residents had requested the flag be flown in the first place and the Union Jack flag flown at significant dates.

Discussion on which flag to be flown and when. Agreed that the Union Jack will be flown on significant dates (Armistice Sunday etc), and the Ukrainian flag to commemorate the start of the war. NP proposed and KW seconded. To take effect when the minutes have been posted on the web.

Several local parish/town councils have taken down the Ukrainian flag and will fly it at the anniversary of the start of the war.

- Notice to residents about Dogs off Leads Notice sent out to residents to remind them to keep dogs on leads when walking them. Also a reminder that no dogs are allowed in the Park.
- Incidents of vehicles nearly driving into obstacles hidden by verges. Two issues - one where a vehicle almost reversed into the pond as they hadn't realised it was there. The other was when someone almost

reversed into some stones. People are not reversing along the road to find a passing place to go into – rather just driving straight onto the verge!

- Autumn Litter Pick. To be decided once verges have been cut.

6. Planning

PL/2023/10812 comments on Clyffe Application for Traveller's Sites

Tockenham Parish Council oppose this application.

The main reason is the prospective increase of heavy vehicles driving through the small, pavement-less village of Tockenham and its very narrow lanes. It would mean further increased damage to the road between West

Tockenham and Greenway. This part of the C120 is in dire need of road surface repairs and despite the Parish Council's formal attempts to resolve the matter we feel, with WC Highways stretched resources, the problem will get worse before it is given any attention. It would also mean increased damage to our verges which are being slowly eroded and destroyed by large vehicles.

We are also concerned about the scale of this development, so close to existing homes, and the impact it will have on the character and appearance of the current landscape.

We would also question the need to supply further Travellers Sites locally. We therefore object to this application."

8. Highway Matters

KW went through the outstanding matters on Appendix A after giving everyone a copy of the form.

Parish Steward Visits, 25th September, 24th October, 27th November and 19th December 2024.

KW has completed and returned the PEAs form and asked for two 'Drive Slowly through Floods' signs in addition the Flood Warning signs already requested.

Deterrent to be fitted by end September by JM's property (to avoid domestic damage).

Grill to pipe at Mermaid – case closed as should be sorted by works in progress.

White railings on side that did not get knocked will remain and reflective posts will be added to the other side.

Speeding – Martin Rose visit to discuss possibilities. Site meeting 6th August with MR and AB, KW. Point into village where we would like 60 mph to 40 mph will not happen. Wiltshire works to government guidelines and conforms to their advice on speed limits etc. Following last year's Metro count we are aware that we will not get our speed limit reduced to 20 mph. The perception of speed being driven is hampered by the narrow lanes in the village. MR has suggested that we go for another Metro count but in four sites to check speed levels in the village. MR has applied for four metro sites to be put down in the village at various places. Once the results are received speed limits can be considered.

85% of average speed will be looked at. If majority of drivers are driving at 20 mph or lower, this may be considered as the required speed.
